NFL Vet returns to coach at Silverton

SILVERTON — The most successful football player to come out of Silverton is coming home.

Silverton High School has hired Scott Gragg as the school's varsity football coach.

Gragg, a 1990 Silverton High graduate and an offensive lineman in the National Football League for 11 years, recently finished his final season with the New York Jets.

Gragg, 33, replaces Tony Smith, who resigned at the end of last season after nine years as the head coach of the Foxes.

Gragg said that there will be growing pains as he adjusts to coaching at the high school level and that he will lean heavily on his experience.

In any profession, Gragg said, a person needs to be a student first before assuming a position of leadership.

"If you are going to be a college professor, you are basically a professional student for eight years," Gragg said.

"I have been a student of the game of football for 11 years professionally and five years at the collegiate level. I've seen what works, and I've seen what doesn't. I've seen what motivates players.

"I'm going to make mistakes. I'm going to go for it on fourth and one, and we are not going to get it. I'm going to punt when people think I

should have gone for it. There is second-guessing at all levels, and that is one of the things that makes the game great."

Gragg said his return to Silverton has more to do with returning to the community than being on the sideline.

"My desire is to do more than impact kids between the chalk lines but in the classroom as well," he said.

Scott Gragg

Age: 33.

High school: Silverton, graduated in 1990.

College: Montana, graduated in 1995 with a degree in mathematics.

Professional career: Drafted in the second round of the 1995 NFL draft by the New York Giants. Played 11 years as an offensive lineman with the Giants, the San Francisco 49ers and the New York Jets. Started seven games at right tackle for Jets this season.

FAMILY: Wife, Toni, daughter Anna, 7, and son Brian, 6.

Gragg graduated with a mathematics degree from the University of Montana. He hopes to start teaching math in the fall, but there may be hurdles to overcome before he takes on a classroom full time.

Gragg is eligible for a temporary teaching license while he gets certification training at Western Oregon University.

"We have to wait and see, but it may be as simple as student teaching for a semester," Gragg said.

Orange is Back!!

My name is Greta Ledford and I am the current Activities Director at the high school, and I am also a graduate from the class of 1998. Our principal, Jodi Drescher brought up the idea of bringing Orange back this past fall, and the idea came to when Scott Gragg was hired as the head football coach.

As a graduate of Silverton High, Scott proudly wore the colors of Orange and Black as many did before him. I believe his graduating class was the last ones before the color change to Silver and Black. So with that, Scott returned to Silverton in hopes of bringing back the Orange. He approached the leadership class, and presented his idea. After Coach Gragg's presentation the leadership class discussed the possibility of this change. They voiced concern for their current student body, of which would lose the school colors they had always known.

Through discussion they also felt sympathy for the alumni that had come before them, and no longer shared the school colors that were once here. By adding Orange in as an accent, it provided the school with colors that represented all classes that had ever graduated from Silverton High.

The leadership students created a petition in which they obtained signatures from the student body in support of the change. Once 30% of the student body signed the petition, the decision went to a vote. During an assembly polling stations were set up, and students cast their vote. Of the student body that voted, 75% voted yes and 25% voted no to return Orange as an accent to the school colors of Silverton High. With the majority ruling in favor of

the change, it became official and Orange was brought back.

As it now stands, Orange is an accent color; we want to clarify that the colors did not go back to only Orange and Black. We hope that with this change all past, present and future alumni of Silverton High will feel that they may wear their school colors with pride.

Honorary Diplomas for 2006

Elmer "St. Elmo" Valkenaar, a graduate of Michigan State University, came to Silverton in 1971 after working in the aerospace industry as a design engineer for 13 years. He is a holder of two patents on a portable pager called "Pagemaster".

He held a mathematics teaching position for 6 1/2 years at the Mt. Angel Seminary High School and also was their varsity coach for soccer, basketball and track.

Elmer or "St. Elmo", as he is affectionately known by the SHS students, started substitute teaching at Silverton High School in 1981 after retiring from a real estate career as a Real Estate Broker and owner of four local offices.

He was the first varsity soccer coach at SHS starting in 1985 and continuing until 1992. He also coached the "throwers" on the SHS track team from 1991 through 1997. And as the Voice of the Foxes Basketball team since 1993 he is a very familiar person to generations of basketball fans and players alike.

Elmer has earned the Silverton Distinguished Service Award in recognition for his many community activities to include Vice President of the Silverton Hospital Auxiliary and is the responsible person for the Vial of Life Program. He can also be seen on almost a daily basis at the Oregon Gardens driving the tram and conducting tours of the facility.

St. Elmo loves the SHS students and they love him.



Charles A. (Chuck) White began teaching and coaching at Silverton High after graduating from Willamette University in May 1973. For 18 years he taught classes in the Social Sciences, primarily personal finance and Economics. He coached football, basketball, and baseball serving as the head football coach for ten years from 1975-84.

In 1990 Chuck became a district administrator serving as Director of Personnel and Curriculum for 13 years until his retirement in 2003-04 from the Silver Falls School District.

As Director of Personnel, Chuck served in leadership roles at the state and national level as president of both the Oregon School Personnel Association and the American Association of School Personnel Administrators. He continues to consult with school districts, help manage Silverton Realty, and work on his Christmas tree farm to complete an active retirement.

During Chuck's 32+ years in the Silverton community he has been active in a variety of kid related and civic activities from coaching youth sports to serving as president of the Silverton Area Chamber of Commerce for three terms. In 1996 Chuck was recognized by the Chamber as Silverton's First Citizen and more recently by the Marion and Polk Family YMCA as 2005 Volunteer of the Year. Chuck is one of the founding directors of the Silver Fox Foundation and an active parish member at St. Paul's Catholic Church.

Word reached the hospital in March that Silverton Hospital has been named one of the nation’s 100 Top Hospitals® for 2005 by Evanston, Ill.-based Solucient®, the nation’s leading source of healthcare research.

Out of nearly 6000 hospitals across the nation, your hometown hospital was recognized as one of the best. In fact, Silverton Hospital was the only hospital of its size in the Northwest to be honored. The award recognizes hospitals that have achieved excellence in quality of care, operational efficiency, financial performance, and adaptation to the environment.

Though the nation is just starting to take notice, Silverton residents have long appreciated the value of their community hospital. Rick Ernst, Class of 1971, wasn’t surprised that the hospital is receiving national recognition, “They’ve got more doctors than beds - you’d be surprised what they can do up there.” He’s right. For a

hospital of its size, Silverton Hospital delivers more than twice the number of babies in its Family Birth Center, boasts one of the state’s first female plastic surgeons, as well as Silverton’s only sleep lab and provides local access to high quality specialty care. They’re also leading the pack technologically. The hospital recently became the first emergency department in the state to use a fully-integrated electronic medical record and tracking system.

Most alumni know that only a few years ago, if you wanted to schedule an MRI or see a specialist you’d be taking time off work to drive to Salem or Portland. Today, Silverton Hospital has 13 specialists including a nationally renowned urologist and one of less than a dozen female plastic surgeons in the state.

The access to specialty medical care and state-of-the-art technology is just icing on the cake for a hospital that was in dire straits 15 years ago. Silverton Hospital was facing financial difficulty, had lost its accreditation and was in real danger of being closed entirely when the Board of Trustees hired Bill Winter as the new CEO. Fifteen years later, the hospital boasts a thriving medical community, eight affiliated clinics, JCHAO accreditation and a workforce 600 strong.

“I have always admired the work of the people at Silverton Hospital,” said Sharon (Jensen) Messman, ’60, “but my respect has grown exponentially during the past 15 years with the administration of Bill Winter.” Messman

works at the hospital in the Patient Access Services Department and says she is glad to give back to her community through her work there. “I am proud to be part of an organization that has expanded – in both heart and knowledge – to better serve our community.”

In fact, Silverton Hospital continues that expanded outreach everyday, working to improve health in the community through quality care, education, lifestyle management and support. Programs reach out to our neighbors at health fairs, through the hospital’s publications and in classes, workshops and seminars with healthcare providers.



Hospital History

Since its humble beginnings as the Keene Hospital, a two-story house used by all local doctors from 1914-1918, Silverton Hospital has grown to meet the ever-changing needs of our community. In 1918, the Water Street Hospital opened in a remodeled residence, complete with operating room and room for 15 beds. That facility was replaced in 1937 with the West Hill Hospital, a modern brick structure that added private patient rooms,

X-ray and a maternity ward to the list of expanding services. The hospital continued its growth with a new Phelps Street Entrance and larger maternity ward in 1947. Today, Silverton Hospital's state-of-the-art facility boasts 49 beds supported by diagnostic imaging, laboratory, operating rooms, emergency department, intensive care unit, high-quality food service and a remarkable Family Birth Center added in 2000. The hospital's latest project is the renovation of the former Health Resource Center into an outpatient clinic for high-tech nursing care, rehabilitation therapy services, diabetes education and the popular Foot Clinic. The former Van Cleave Clinic was acquired in 1991, and will now be called the Phelps Street Annex.

These newsletters are sent bulk mail to keep postage costs to a minimum. If one is returned as undeliverable, it costs us an additional 60¢. SHSAA Start-up

In 1993 the Class of '63 could not find a reasonable use for approximately \$900 of their funds left over from their recent 30th reunion. After some discussion of possible alternatives, they decided that a scholarship would be appropriate. Then their thought turned to instead of one blast to one student that just maybe the funds could be "seed" money to establish a continuing scholarship program.

Mason Branstetter, a member of their reunion committee, met with the Directors of the Silver Fox Foundation and asked them if they would provide a temporary legal shelter for an Alumni Association while they organized. They agreed, however, during the immediate following period of several years, not much was accomplished along the road to the creation of the SHSAA because simply the Association consisted of three members, as Mason has been heard to say, "Me, myself and I."

Around 1996, Dave Gentry met with Mason stating that he had heard of the Alumni Association that was being started. Hurray! Now there were two real members. On May 10, 1996 the first real meeting was held with the following in attendance: Milt Baum, Mason Branstetter, Earlene Ertelt, Dave Gentry, Jeanette Olafson and Chuck White. The financial report was \$2,033.75. Among the New Business, as we did not have any "Old Business" at that time, was the motion to award our first scholarship in the amount of \$100 to Emily A. Wallace. We also established a goal of reaching \$100,000 in an investment account

and that scholarships would only come from the interest earned on the invested principal.

Now, almost 10 years later, with over 1,000 alumni who are either currently paid as full members or have at some time paid their 5 buck annual dues on the record; we continue to grow exponentially. Also, after much effort by several members, we have created and maintain a databank of over 13,000 alumni from SHS starting with the first 3-year graduation class of 1908. It should be noted that the first 4-year graduation class was 1909.

Our first major contributor was Verl Cochran. I am sure that most of you remember him as the ever present Fox fan at every home and away game for many years. As the owner of the school bus lines as well as holding many other positions of responsibility at the ol' High School, he was always there to lend a helping hand. Well, his helping hand this time was our first significant donation, which put our investment account in the 5-figure range for the first time.

We could mention many, many more of you; however, the space is limited and some of you have asked that your donation be kept confidential. Out of respect for your wishes and also in an effort to keep the story short, let's just say again, "Thank you very, very much for your confidence in our organization and your generosity for your fellow Foxes."

Unbelievably, we have managed to accumulate an amazing investment principal in excess of \$225,000. It is extremely emotional to witness the financial outpouring

from our fellow Foxes. On one occasion, a check arrived at our office in a "window" envelope and it appeared to be a solicitation for the Association to participate some fund raising effort for another organization. So, you can imagine the surprise when it was opened and there was a check from a 1949 Silverton High alumni in the amount of \$50,000. Boy, there was some celebration that day!

Believe us, however, that every donation is appreciated. For those who are inclined, it is important to remember that as a federally recognized Not-for-Profit Corporation, donors can get tax credit because of our section 501 (c) (3) status. So, for every \$100 that you send our way, you will get approximately \$40 tax credit. The \$40 figure is computed from an approximate 31% federal and a 9% State of Oregon income tax bracket donor. So, we ask you to spend your federal monies wisely and have it be a significant part of our SHS scholarship fund. Better here than a number of other uses. Our federal tax ID is: 20-2021613. We will send you a receipt for your tax records.

Let's not forget, that this is first and foremost an organization of people. Money is important and scholarships are our main reason for existence, but following very closely is the principle of alumni relationships. Without the unselfish support of all of you who help with the class reunions and the many extremely loyal and dedicated stalwarts of the SHSAA who are directly responsible for the Association activities to include the Newsletter and the annual Garden Party, we would simply wither up and blow away.

SHS or SUHS, depending upon the years you attended is very unique. It has many "firsts" to its credit. Even though our Alumni Association may not be a first in matters of time in relationship to being organized in support of a high school, we can hold our heads high as being second to none when it comes to being one if not the strongest high school alumni association in the State of Oregon.
